2025-26 TUITION & FEES INFORMATION

Enrolment for the 2025-26 school year is open to children with deposits due March 15th, 2025. Added this year are two fees, and please note the change from the previous year in the timeline for payments.

1. **Activity Fee** - this will cover various curriculum based activities throughout the school year, including off campus field trips, and replace the ongoing charges throughout the school year.
2. **Capital Improvement Fee** - this will build an account to help us fund necessary classroom renovations, furniture replacement, and equipment upgrades.

Non-refundable Enrolment Deposit

- A non-refundable enrolment deposit of \$1500 is due by March 15th, or within two weeks of acceptance for offer letters made after that date. This will be applied to your first invoice.

Uniform: \$500-\$750 (approximate)

Hot Lunch: \$200-\$600 (approximate and optional)

Individualized Learning Support: \$7500 (where applicable)

Sibling Discount For Local Day Students

- Families with more than one child enrolled in Kindergarten to Grade 8, will pay full tuition for the oldest child, and receive a 10% discount on each of the younger sibling's Annual Tuition.
- Siblings enrolled in the Cathedral School Junior Kindergarten are not eligible for a sibling discount.

Enrolment Deposit: \$1500

Your non-refundable deposit will secure enrolment for the upcoming school year. This deposit is due by March 15th or, for new students, within two weeks of acceptance offer letters made after that date. This deposit will be applied to the student's fees in June.

Payment Deadlines and Options

Tuition fees are due according to the payment option you choose. Choosing to pay in installments or by month does not constitute a fractional contract.

Late Payments

1.5% interest will be charged to your account on balances that are overdue. To avoid interest being charged to your account, please pay your statement balance in full before the end of the month.

Returned Payments

Cheques or pre-authorized debit payments returned by the bank are subject to a \$25 fee. The returned payment fee will be charged to your account on the date the payment reversal is received by the bank.

Withdrawal from School

The tuition fees are, in part, to reserve your child's place at Cathedral School. Early withdrawal does not reduce staffing needs or other costs. Accordingly, the withdrawal of your son or daughter from the school does not entitle you to a refund. Payments made up until, and at the time of withdrawal may not be refunded.
